1. This Proposal has been filed by applicant school to determine fees for the year 2024 – 25, 2025 – 26 & 2026 – 27.
2. Applicant school is affiliated with CBSE Board.
3. School is English medium school.
4. School is situated at same as above.
5. This Proposal is for Std. 1st to 12th General and Science.
6. This school is registered with 24220809909 U – dis number.
7. School has filed this proposal on 29-08-2023 to determine fees for the year 2024 – 25, 2025 – 26 & 2026 – 27. We have gone through the proposal files and determined the provisional fees on 29/05/2025. The said order was collected by the school on 06/06/2025. Being aggrieved by the said order the school has filed its objection against the order of provisional fees dated 10/06/2025. On 03/06/2025 this committee issued a notice and asked school to submit several documents and accounts details. On 30/06/2025 this committee again issued a notice for physical hearing. On 03/07/2025 due to insufficient documents and account details the hearing adjourned. On 28/07/2025 this committee again issued a notice for physical hearing.
8. On 31/07/2025 Mr. Gunsai Manoj, Administrative, Mr. Amitkumar Tarway, IT Admin and Mr. Vipul, Accountant of the school appeared before the committee and hearing was conducted. During hearing, it is submitted by Mr. Manoj that school has spent Rs. 1,19,60,752/- towards salary in year 2024-25, to verify the said amount, this committee asked Mr. Manoj to submit Salary Certificate issued by Bank and therefore the school had produced salary certificate issued by Kotak Bank of Rs. 1,13,98,554/- of year 2024-25. Considering above facts, inflation rate, requests made by authorized person of the school and amenities provided by the school, this committee determine final fees for the year 2024-25, 2025-26 and 2026-27 as under:
